Mr. Yameen is an expert in the Palestinian Agricultural sector, with over 20 years of experience working with various stakeholders on the technical, developmental and export side of several agro-businesses and NGO's throughout the West Bank. Besides his other roles he is acting as Agricultural insurance Expert for the first Agricultural insurance company in Palestine namely Al Baraka for Islamic Insurance , he contributed to build insurance policies in several agricultural subsectors , Plant production; green houses and palm dates as well in the livestock in particular poultry ,

Mr.Yameen has promoted the agricultural insurance via diverse segments of farmers mainly small and medium scale along the north and middle of the west bank in Palestine. On the other hand he conducted several negotiation sessions with international reinsurance companies
